In accordance with the requirements of the Securities Act No. 41 of 2016, Airtel Networks Zambia plc. ("the Company") is pleased to announce its unaudited results for the six months period ended 30" June 2025.

HIGHLIGHTS

The following are the key highlights for the quarter under review

- a. Customer base stands at 11.81 million, up 12.8% YoY.
- b. Total Revenues at ZMW 4,137 million, up 30.4% YoY.
- c. Operating profit at ZMW 1,458 million, up 31.9% YoY.
- d. Profit after tax up to ZMW 674 million from ZMW 427 million in prior year. This was mainly driven by revenue growth and strong operating efficiencies.
- The Board of Directors of the company have approved an interim dividend of ZMW 3.51 per share.
