**TRADING STATEMENT**

The Board of Directors of British American Tobacco (Zambia) Plc (“**the Board**”) wishes to advise the Shareholders that for the period ending 30<sup>th</sup> June 2021, the basic earnings per share is expected to be between 258% higher than that of the corresponding period last year for both the group and for the Company.

The increase was mainly attributable to optimal pricing strategies and an improved product mix.

The Company expects its results for the half-year ended 30<sup>th</sup> June 2021 to be released on SENS and published in the local press on or about 20<sup>th</sup> August 2021. Accordingly, shareholders are advised to exercise caution when dealing in the Company’s securities until publication of the results.
