TRADING STATEMENT

In accordance with Section 3.4(b) of the Lusaka Securities Exchange (“LuSE”) Listings Requirements, the Board of Directors of CEC Renewables Limited (“CEC R” or “the Company”) hereby wish to advise the shareholders of the Company that the Earnings Per Share (“EPS”) for the half year ended 30th June 2025 is approximately 236% higher than that of the half year ended 30th June 2024.

The Company recorded a significant increase in EPS for the half year, primarily driven by a higher solar PV generation output from the 60MW Itimpi 1 Solar PV Plant, which has remained fully operational throughout the reporting period. This contrasts with the first half of 2024, when the solar plant only became operational in the second quarter.

Shareholders are advised that the information in this trading statement has not been reviewed or reported on by the Company's external auditors.

The Company expects its results for the half year ended 30th June 2025 to be released on SENS and published in the local media on or about 7th August 2025. Accordingly, shareholders are advised to exercise caution when dealing in the Company’s securities until publication of the results.
