TRADING STATEMENT

In accordance with the Lusaka Securities Exchange (“LuSE”) Listings Requirements, the Board of Directors of National Breweries Plc (“Natbrew or “the Company”) hereby advises the Shareholders of the Company that the Loss Per Share for year ended 31 March 2020 is expected to be **203%** higher than **that** of the corresponding period last year for the company.

The company faced significant headwinds in the year under review. Margins were eroded due to the high levels of inflation which triggered widespread escalations in local costs while the softening exchange rate was responsible for substantial increases in the prices of imported packaging materials and other inputs.

Shareholders are hereby advised that the information contained in this trading statement has not been reviewed nor reported on by the external auditors of the company.

The Company expects its results for the period ended 31 March 2020 to be released on SENS on or about 8 June 2020. Accordingly, shareholders are advised to exercise caution when dealing in the Company’s securities until publication of the results.
