

# STOCKBROKERS ZAMBIA WEEKLY EQUITY AND ECONOMIC REPORT

Lusaka Securities Exchange Zambia 15 Aug 2025

#### **Market Commentary**

The Lusaka Stock Exchange All Share Index (LASI) excluding ZCCM-IH gained by 2.75% w-o-w to close at 22,117.05 points.

In terms of turnover, the market closed at ZMW 39.32M (USD 1.69M) over 3.14M shares traded, marking a significant increase to last week's ZMW 24.89M (USD 1.07M) on 1.43M shares. The highest  $\overline{_{\text{USD/ZMW FX Rate: 23.2608}}}$ turnover contributor this week was CHILANGA at 41.55%.

2.12M units traded this week for the market's listed REIT Real Estate USD recording a turnover of USD 169,070 (ZMW 3.92M). Furthermore, no price action was recorded this week.

BATZ was the lead price gainer on the exchange recording an increase of ZMW 2.00 (USD 0.09) or roughly 23.53% to close at ZMW 10.50 (USD 0.45). On the loss side, CHILANGA dropped ZMW -0.03 (USD 0.00) or approximately -0.10% closing at ZMW 30 (USD 0.45).

On the foreign exchange market, the Kwacha Depreciated against the following: GBP (-1.09%), ZAR (-0.82%), EUR (-0.45%), and USD (-0.11%).



#### LuSE July 2025 News Flash

During July 2025, the Lusaka Securities Exchange saw a 142.11% increase in turnover, reaching k298.84 million, with volume also increasing by 32.23%. The All Share Index closed at 21,041.02 points, marking a 4.09% rise, and the market capitalization reached K 304.52 billion, including Shoprite Holdings. The market recorded a net outflow of USD 9,607,277 during the same period.

#### **Zambeef BII Pref Shares Redemption Update**

This announcement from Zambeef Products PLC concerns British International Investment PLC (BII)'s 2016 investment, which included 52.6 million ordinary shares and 100,057,658 convertible redeemable preference shares. After September 16, 2024, BII's conversion rights on the preference shares changed from one-for-one to one-for-3.0833 ordinary shares. Shareholders are advised to exercise caution when dealing with the company's securities.

## **REIZ Court Case Update**

Real Estate Investments Zambia PLC (REIZUSD) issued a cautionary notice on August 14, 2025, regarding an ongoing court case related to the Lewanika Mall involving Forli Limited and the City of Lusaka Football Club. The court of appeal granted orders staying the execution of the High Court judgment pending the appeal, with the appeal process ongoing. Shareholders are advised to exercise caution when dealing in securities/

#### **CCAF AEDC Takeover Update**

CEC Africa Investments Limited (CECA) issued a cautionary announcement regarding developments in Nigeria concerning the purported takeover of AEDC by BPE, referring to the original announcement on December 15, 2021. The court dismissed joinder applications related to the case on June 30, 2025, and the matter was adjourned to October 23, 2025, for further hearings. Shareholders are advised to exercise caution when trading the company's shares.

#### Mafs 9th Agm Notice

Madison Financial Services PLC (MFIN) has announced its 9th annual general meeting (AGM) to be held on August 22, 2025, at the Intercontinental Hotel Lusaka, and virtually via a provided link. Key agenda items include the adoption of minutes, financial statements, appointment of auditors, director appointments and retirements, and a special resolution concerning a waiver of a mandatory offer.

#### Natbrew 57th Agm Notice

National Breweries PLC (NATBREW) announced that its 57th annual general meeting (AGM), initially scheduled for August 14, 2025, has been rescheduled to September 5, 2025, at 15:00 hours. The AGM will be held virtually via the Corpserve Zambia E-AGM platform. Key agenda items include adoption of the minutes, director reports, dividend approval, and election of the board.

#### CEC Renewables HY 2025 Financials - Revised

CEC Renewables reported a 35% increase in revenue to USD 4.657 million for the half-year ending June 30, 2025, with profit after tax rising to USD 671,000, a 236% increase. Generation increased to 80.75 GWH, 32% higher than in 2024, although net debt grew by 39% to USD 58.505 million due to capital investment. The company is expanding with capex reaching USD 42.075 million.

#### **Bata FY 2024 Dividend Notice**

Zambia Bata Shoe Company PLC announced a final dividend of 15 ngwee (K 0.15) per share for the period ending December 31st, 2024, approved at the July 29th, 2025 annual general meeting. Shareholders registered by the close of business on August 29th, 2025, will receive the dividend, with payments starting September 1st, 2025. The last trading day to be eligible for the dividend is Tuesday, August 26th, 2025.

#### Changes to GRZ T-Bill yields

As per Aug 2025; The 273D T-Bill rose 0.50% to close at 13.50%.

#### Changes to GRZ Bond yields

As per Aug 2025; The 3Y bond dropped -1.00% to close at 15.50%.
