

STOCKBROKERS ZAMBIA WEEKLY EQUITY AND ECONOMIC REPORT

Lusaka Securities Exchange Zambia 19 Sep 2025

Market Commentary

The Lusaka Stock Exchange All Share Index (LASI) excluding ZCCM-IH gained by 1.85% w-o-w to close at 25,132.96 points.

In terms of turnover, the market closed at ZMW 53.21M (USD 2.25M) over 2.09M shares traded, marking a significant increase to last week's ZMW 21.64M (USD 913,813) on 1.64M shares. The highest turnover contributor this week was CHILANGA at 82.88%.

47,713 units traded this week for the market's listed REIT Real Estate USD recording a turnover of USD 2,319 (ZMW 54,805). Furthermore, no price action was recorded this week.

AECI was the lead price gainer on the exchange recording an increase of ZMW 21.98 (USD 0.93) or roughly 28.17% to close at ZMW 100.00 (USD 4.22). On the loss side, CEC dropped ZMW -0.11 (USD 0.00) or approximately -0.43% closing at ZMW 25.72 (USD 4.22).

On the foreign exchange market, the Kwacha Appreciated against the following: GBP (1.22%), USD (0.77%), ZAR (0.72%), and EUR (0.45%).

PUMA HY 2025 Financials

Puma Energy Zambia PLC announced unaudited results for the half year ended June 30, 2025, revealing a net loss after taxation of ZMW 154.29 million, with revenue at ZMW 5,642.604 million. the company's financial performance was affected by a 27% revenue decline due to volume contraction and persistently low margins. Management is responding by working to enhance operational efficiency.

CEC Change In Directorate

Copperbelt Energy Corporation PLC (CEC PLC) announced the retirement of Mr. Hastings Mtine as director, effective August 31st, 2025, after joining the board on October 17th, 2022. The announcement, approved by the Lusaka Securities Exchange, the Securities and Exchange Commission, and CEC, was made on September 15th, 2025.

Chilanga HY 2025 Dividend Notice

Chilanga Cement PLC announced an interim dividend of ZMW 2.00 per share for the half-year ending June 30, 2025, approved by the board of directors on September 11, 2025. The dividend will be payable to shareholders registered as of close of business on October 10, 2025, with the last day to trade and qualify for the dividend being October 7, 2025. Dividend payments will be posted on or about October 13, 2025.
