The LuSE All Share Index closed at 20,579.11 points showing a negative change of 0.22%, due to a significant decrease in the Copperbelt Energy Corporation (CEC) stock price of 0.59%, closing at ZMW 21.87

A total of 505,698 shares traded today representing a total turnover of ZMW 1.76 (USD 75,754.04). Standard Chartered Bank (SCBL) was the largest contributor to the turnover representing 67.93%. SCBL traded a volume of 433,714 shares representing 85.77%, making SCBL the largest volume contributor

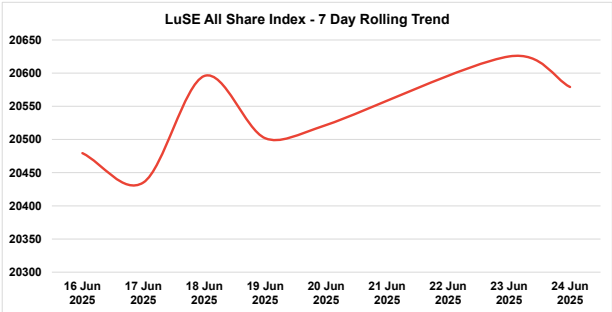

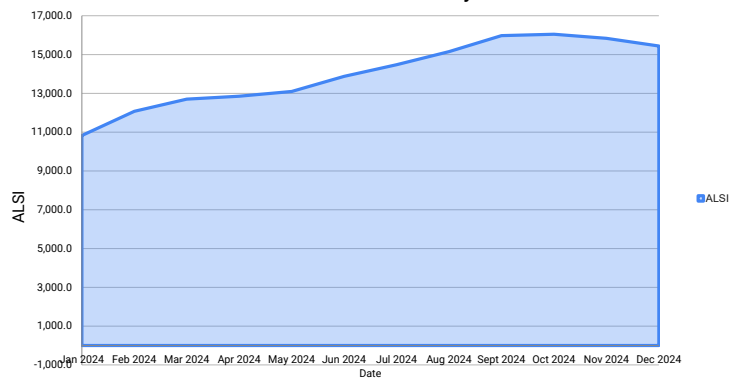

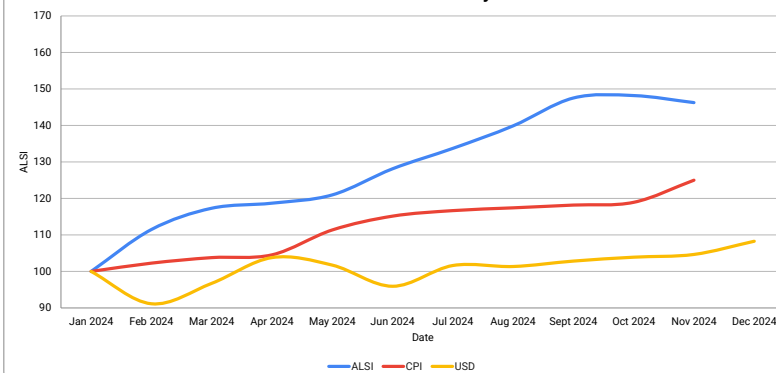

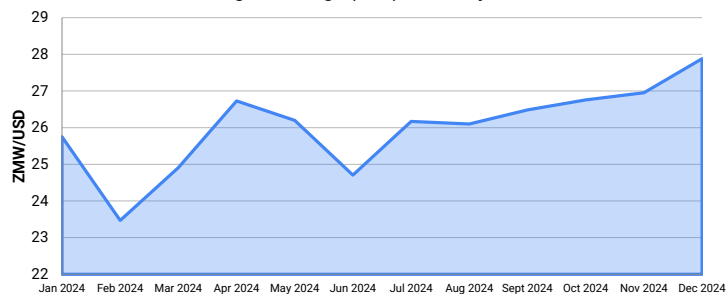
LuSE All Share Index - Monthly Trend
