In accordance with the Lusaka Securities Exchange (“LuSE”) Listings Requirements, the Board of Directors of Zambia Reinsurance PLC (the “Company”) hereby advises the Shareholders of the Company that the Earnings per Share (EPS) for the period ended 30 June 2025 is expected to be above that of the prior period ended 30 June 2024 by 66.67%.

The movement in EPS is primarily due to business growth during the review period, which resulted in higher reinsurance revenue and consequently a rise in EPS.

Shareholders are advised that the information contained in this Trading Statement has not been reviewed nor reported on by the external auditors of the Company.

The Company expects its results for the half-year ended 30 June 2025 to be released on SENS and published in the local press on or about **26 September 2025**. Accordingly, Shareholders are advised to exercise caution when dealing in the Company’s Securities until publication of the results.
