## TRADING STATEMENT

In accordance with the Lusaka Securities Exchange ("LuSE") Listing Requirements, the Board of Directors of ZAMEFA (the "Board") wishes to advise the Shareholders that for the financial year ended 30th September 2025, the basic earnings per share ("EPS") is expected to be between 2.18 Kwacha per share and 2.51 Kwacha per share, being a decrease of between 67% and 62% when compared to EPS of 6.62 Kwacha per share of the prior year.

The decrease in the EPS is primarily due to:

- A change in the sales mix of product sold during the year,
- The negative effect of the strengthening of the Zambian Kwacha against the United States Dollar ("USD") on the revenue and cost of sales which are largely USD denominated in the second half of the year and,
- A decrease in the overall volumes sold in the 2025 financial year, as a result of the constrained liquidity in the local market affecting some of our major customers

The Company expects its results for the year ended 30<sup>th</sup> September 2025 to be released on SENS and published in the local press on or about 19<sup>th</sup> November 2025. Accordingly, shareholders are advised to exercise caution when dealing in the Company's securities until publication of the results.
